Terms and conditions for the allotment of space at the Nagara Pete

Application for the space shall be made at least 3 days in advance. Rangoli, Metro Art Center (R-MAC) has the right to accept or reject the proposals for selling art & crafts at the Nagara Pete. Submission of application cannot lay claim to the desired dates at the Pete, even though the dates might be available.

Once the application is accepted and the dates are confirmed, the applicant will have to make complete payment to confirm the booking. The applicant will also have to fill a form with terms and conditions, attached along with this booking procedure. The form can also be downloaded from our website: www.bmrc.co.in

1. Payment Terms:

- a) All the Cheques/DD will be made in the name of Bangalore Metro Rail Corporation Limited and payable in Bangalore.
- b) All information regarding the booking or cancellation of the Pete space must be in writing.
- c) The R-MAC reserves the right to remove the items exhibited for display or sale if it is controversial or socially disturbing or opposed to public policy the decision of R-MAC in this regard is final.
- d) Bookings are non-transferable.

2. Terms of utilization of the Space offered:

- a) Pete space will be handed over to the exhibitor on Thursday of the week at 9:00 am for setting up the stall. Sales can commence from 10 AM. No rebate will be given for the loss of day (s) due to failure of set up the stall.
- b) The use of nails, staples, glue, tape, both side adhesive tape and anything that damages painted walls are strictly prohibited.
- c) Exhibitors can make their own arrangements to have loose furniture within the space allotted for exhibiting their wares. The furniture so brought must be removed on the last day, in failing to do so; R-MAC will remove the same and dispose it off at its discretion without giving any compensation to the exhibitor, without Notice to the Exhibitors.
- d) R-MAC and BMRCL is not responsible for the loss or damage to the personal belongings of the exhibitor.
- e) R-MAC will not provide any storage space for the products exhibited for sale. The Exhibitor can bring a trunk and lock the goods in the space allotted and leave it behind overnight at their own risk.
- f) The Pete space should be clean and vacated by 9:00 pm on the last day i.e. Wednesday of the week.

3. Cancellation:

Only those cancellations made 15 days prior to the confirmed date of the Pete space will be refunded with 100% booking amount.

4. Timings:

The Nagara Pete is open to public from 10: 00 am to 7:30 pm, 7 days a week.

5. Closing the show:

- a. The Exhibitor shall comply with the following timings:
The exhibition should close by 7:30 pm each day. On the concluding day, the Pete space must be vacated by 8: 00 pm and there after R-MAC will check the space whether it is in good condition.
- b. Any poster or banner for an event should be displayed only at the designated places and after clearance by the office of R-MAC.
- c. R-MAC will not undertake to advertise or do media relations works for any of the shows/ events organized. However the organizers/ exhibitors are requested to give a clear indication of the nature of the exhibition and other promotional information, including posters, catalogue, photographs, press releases and invitation cards etc. to the Curator one week prior to the event to facilitate inclusion in the R-MAC calendar of events (subject to date of submission of photographs/ promotional information, and the publication of the calendar) and the R-MAC website. The R-MAC reserves the right to use or edit the information provided. R-MAC will permit media interviews and reviews.
- d. The organizers are not allowed to use the BMRCL logo in the invitations or posters without the permission of the BMRCL.

6. General Conditions:

- a. In case the exhibitors or their associates misbehave with the R-MAC staff or the general public, the R-MAC reserves the right to terminate the space allotted with immediate effect and without notice.
- b. Exhibitors cannot use liquor or tobacco sponsorship, or any commodity prohibited by law.
- c. The entire boundary of the boulevard is a no smoking zone.
- d. The R-MAC will not be responsible for any damage done to the exhibits brought for sale.
- e. Use of double sided tape on walls, nails placed on walls, the requirement of extra lighting and open wiring will not be permitted for the hanging of an exhibition in the Pete Space.
